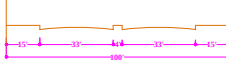

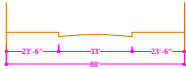
ROAD CROSS SECTION



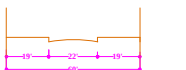

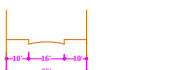
